Magistrates Court rate per annum, determined on a daily basis, on all monies then outstanding.
3. Martin Ag reserves the right to charge a monthly administration fee on overdue accounts.
4. Martin Ag reserves the right to accept or decline any order in whole or in part.
5. Martin Ag reserves the right to change prices without notice.
